## **Motivations**

#### **Members**

"The consolidation of multiple PDLs into one unified list ensures patients will no longer face the disruption of transitioning between effective therapies if they switch plans."

#### **Providers**


"...a unified PDL will greatly reduce the administrative burden of dealing with six different PDLs and PA criteria."

#### **Economics**

"Savings associated with transitioning from multiple MCO operated PDLs to a single, state directed PDL total \$21,131,265 in general funds."

## What this Looks Like for South Carolina...

### SCDHHS will adopt a single, state state-directed PDL effective July 1, 2024

#### For classes included on the SCDHHS PDL:

- Plans must cover preferred medications
- Any criteria to access medications must be **no more restrictive** than those applied by FFS

#### For classes not included on the SCDHHS PDL:

Plans will <u>likely</u> maintain some ability to manage utilization

### The breadth of the SCDHHS PDL will expand in the future...

Some high-cost drug classes are not currently included

### ...But not right now

SCDHHS has signaled <u>no significant PDL changes</u> prior to the July1 go-live, and likely not until October



## What this Looks Like for South Carolina...

### SCDHHS will adopt a single, state state-directed PDL effective July 1, 2024

#### "Grandfathering" will allow us all to ease into this transition...

Members will be able to continue current therapy through September

#### ...But not for brand-preferred-over-generic scenarios

Those scenarios will require a switch on July 1

### Pharmacy reimbursement is not addressed by the single PDL implementation

> The Independent Community Pharmacy Directed Payment Program will continue

### SCDHHS officially "advised" the single PDL at the February 13, 2024 MCAC meeting

- Those documents are available on the SCDHHS website
- Additional formal guidance from SCDHHS is forthcoming

## Managed Care Organizations (MCOs)

- > Annual Reviews & Ongoing Activities After Unwinding Period Ends
- ➤ Single PDL Implementation 7/1/2024
- ➤ New MCO Contract 7/1/2024
- > S.915 and Health Agencies Reorganization

## Medicare/Medicaid Plans (MMPs)

- > SCDHHS operationalizing Dual Managed Care Program
  - Waiver Authorities and State Plan Amendments
  - Effective January 2026
  - Update on SCDHHS Plan Expected Soon



## **Annual Review Strategy**

- > SCDHHS expects to complete initial annual reviews by June 2024.
- The annual review process will continue monthly thereafter.
- Status of 1902(e)(14) waiver flexibilities expected to be continued through CY 2024 at a minimum according to CMS



## **SC Annual Review Facts**

- ➤ Total members reviewed for eligibility 1,046,263
- **→** Total Renewals 523,014 (50%)
  - ✓ Total members reviewed and renewed -262,975 (50%)
  - ✓ Total members renewed on ex-parte basis 260,039 (50%)
- **→ Total Disenrollments 272,195 (26%)** 
  - ✓ Total members reviewed and disenrolled 101,173 (37%)
  - ✓ Total members disenrolled for failure to return form 170,753 (63%)
  - ✓ Total members disenrolled for other procedural reasons 269 (0%)
- ➤ Pending Reviews 251,054 (24%)
- ➤ Percent of annual reviews successfully delivered 92.61%
- ➤ Percent of annual reviews returned within initial 60-90 days 33.54%
- ➤ Percent of annual reviews returned within the grace period 7.02%






